

FOLK LIPTOV FESTIVAL – RULES

16.12.2017

DOM KULTURY, LIPTOVSKY HRADOK

DANCE CATEGORIES:

1. Slovak folk dance – dance competition
2. Slovak folk dance and Folk dance of other nations - festival

CATEGORIES FOR SLOVAK FOLK DANCE:

1. Classic folk (authentic)
2. No-classic folk (with new dance elements)

CATEGORIES FOR SLOVAK FOLK DANCE AND ALSO FOR FESTIVAL:

SIZE GROUPS:

1. Small (5- 9 performers)
2. Large (10 and more performers)

AGE DIVISIONS are determined as of JANUARY 1ST 2017.

Therefore, registered ages of all entries must be bumped up to the dancer's age as of January 1, 2017.

Age Divisions:

1. Mini – under 9 y.
2. DVK– 9 – 12,99 y.
3. Junior – 13 – 15,99 y.
4. Adults 1 – 16 – 30,99 y.
5. Adults 2 – over 31 y.

EXCEPTION:

MINI age categorie – AVERAGE AGE IS DETERMINED!

Small Groups – 2 performers might be at 1 year older than upper age level (f.e. Small Juniors group can have 2 performers at the age of 16.99year)

Large Groups – 20% performers might be 2 years older than upper age level (f.e. Large Junior Group can have up to 20% % at the age of 16.99year)

All Contestants within a group will be responsible for showing proof of age to the Competition Director should a question arise. Failure to comply with the age proof of ALL Contestants could result in drop on the last place .

TIME LIMITS:

Small groups: 2:00 min. - 4:00 min., setting up props- 2min.

Large Groups: 3:00 min. - 6:00 min., setting up props- 2min.

Extended performance time is not available!

ENTRY FEE:

1. Slovak folk dance – dance competition – 3EUR/ performer

2. Folk dance of other nations – festival

Small Groups – 15EUR/ performance

LargeGroups – 30 EUR/performance

No entries will be processed without full payment

AWARDS:

All performers receive a Certificate

Slovak folk dance – dance competition – 1.,2. and 3. Place + additional awards

Folk dance of other nations – festival – based on the judge's view

MUSIC:

All music sounds have to be sent on Email Adress: majsterzvuku@gmail.com, in **MP3 or Waw Form**, plus signed with the dance group's name + name of performance.

DUE DATE FOR MUSIC: 10.12.2017

There will be a 5EUR late fee per act after the deadline date

JUDGING AND SCORING CRITERIA

Each performance will be evaluated on the following five judging elements:

1.) Technique – 20 points total

2.) Choreography – 20 points total

3.) Overall Appearance – 10 points total

Penalty

Extended performance up to 15 sec. for a 3 penalty points of the total average

Extended performance over 15 sec. for a 5 penalty points of the total average

Extended performance for props for a 2 penalty points of the total average

In case of ONLY one performance in the group:

Total average: 34,00 and over - 1. Place,

Total average: 28.00-33.99 - 2. Place,

Total average: 19.00 – 27.99 - 3. Place.
